A RESOLUTION INCREASING THE SEWER AND WATER SERVICE RATES, FEES AND CHARGES OF THE EAST LAKEWOOD SANITATION DISTRICT FOR 2025.

WHEREAS, the Board of Directors of the East Lakewood Sanitation District ("District") adopted the District's 2025 Budget on November 20, 2024, following a budgetary process that began in September of 2024; and

WHEREAS, in connection with the adoption of the District's 2025 Budget, the Board reviewed the District's revenue requirements for 2025 and determined that it is necessary to increase the District's water and sewer service rates for 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EAST LAKEWOOD SANITATION DISTRICT, JEFFERSON COUNTY, COLORADO:

Section 1. All rates are list in Exhibit A, attached.

Section 2. <u>Bi-Annual Collection.</u> All District sanitary sewer service rates are billed biannually and such bi-annual billing shall remain in force and effect until further action of the District's Board of Directors.

Section 4. **Effect of Adoption.** The rates, fees and charges adopted by this Resolution shall remain in effect until further action of the District's Board of Directors.

Section 5. <u>Public Health and Necessity.</u> The Board hereby determines and finds that the adoption of this Resolution is necessary for and promotes the public health, welfare and safety of the District and its inhabitants.
